MECHANICALLY FASTENED TWO PLY SBS ROOFING SYSTEM ON WOOD

- ERECT SCAFFOLDING AND DEBRIS CHUTE FROM THE FIRST FLOOR BALCONY TO THE UPPER ROOF LINE AND STAGE THE DISPOSAL BIN IN THE ALLEYWAY COMPLETE WITH A 6' PEDESTRIAN WALKTHROUGH AS PER THE REQUEST FROM THE CITY OF NORTH VANCOUVER
- VACUUM EXISTING GRAVEL ROOF BALLAST TO EXPOSE THE BUILT UP ROOFING FELT MEMBRANE
- REMOVAL OF EXISTING BUILT UP ROOFING SYSTEM WITH COMPLETE DISPOSAL
- INSPECT THE EXISTING PLYWOOD DECK TO ENSURE A SOUND SUBSTRATE FOR THE NEW ROOFING SYSTEM AND REPORT BACK TO THE STRATA WITH ANY ISSUES THAT MAY NEED TO BE COMPLETED ON A TIME AND MATERIAL BASIS
- MECHANICALLY FASTENED IKO FAST-N-STICK BASE SHEET OVER THE PREPARED ROOF SUBSTRATE WITH TRUFAST MEMBRANE PLATES AND FASTENERS
- FULLY ADHERE IKO ARMOURBOND 180 BASE SHEET STRIPPING AT ALL PARAPET WALLS AND CURBS ONCE PRIMED WITH IKO SAM PRIMER/ADHESIVE
- FULLY TORCH IKO TORCHFLEX TP-250 CAP SHEET TO THE MECHANICALLY FASTENED IKO FAST-N-STICK BASE SHEET
- FULLY TORCH IKO TORCHFLEX TP-250 CAP SHEET STRIPPING AT ALL PARAPET WALLS AND CURBS

- REMOVAL AND REPLACEMENT OF FIFTEEN (15) EXISTING SKYLIGHTS WITH NEW FIXED CURB MOUNTED SKYLIGHTS MANUFACTURED BY COLUMBIA SKYLIGHTS

WHILE EVERY EFFORT IS MADE TO MINIMIZE THE PROBLEM, DUST AND DIRT MAY FALL INTO THE BUILDING DURING CONSTRUCTION. WE RECOMMEND THAT YOU COVER ANY SURFACE THAT MAY BE SUSCEPTIBLE TO DAMAGE AND TAKE DOWN ANY IRREPLACEABLE KEEPSAKES OR OTHER SENTIMENTALS FROM CEILINGS AND WALLS TO ELIMINATE ANY CHANCE OF DAMAGE. THE CONTRACTOR IS NOT RESPONSIBLE FOR MINOR DRYWALL DAMAGES CAUSED BY SHIFTING OF THE BUILDING DURING CONSTRUCTION. THE DEMOLITION AND INSTALLATION PHASE CAN CAUSE MOVEMENT THROUGHOUT THE STRUCTURE CAUSING THE DRYWALL MUD OVER THE SCREWS TO FALL OFF AND HAIRLINE CRACKS TO APPEAR. THIS WILL BE THE RESPONSIBILITY OF THE OWNER AS THERE IS NOTHING THAT CAN BE DONE TO PREVENT THIS FROM HAPPENING. THE CONTRACTOR IS NOT RESPONSIBLE FOR ANY EXISTING WINDOW/SKYLIGHT TRIM DAMAGE. OVER TIME THE PVC TRIMS CAN BE AFFECTED BY UV RAYS AND MOISTURE AND COULD BREAK UPON THE REMOVAL OF ANY WINDOWS/SKYLIGHTS.


